WHEREAS, Garlock Inc., an Ohio corporation now dissolved and formerly having a mailing address at 1666 Division Street, Palmyra, New York 14522-9350 ("ASSIGNOR"), having previously executed on December 31, 1997 a Trademark Assignment (attached hereto as Exhibit A) of certain trademarks, service marks, trade names, trademark registrations and trademark applications to Coltec Industrial Products Inc., but having incorrectly identified the state of incorporation of Coltec Industrial Products Inc. as "the state of Delaware," now wishes to correct this inadvertent error in a form acceptable for recordation by the U.S. Patent and Trademark Office;
