RELEASE OF PATENT AND TRADEMARK COLLATERAL SECURITY INTEREST

WHEREAS, pursuant to the Assignment of Security Interest in United States Patents and Trademarks dated as of March 29, 2001 (the "Security Document") between Home Diagnostics, Inc., a corporation organized and existing under the laws of the State of Delaware ("HDI"), as assignor, and Bank of America, N.A., a national banking association (the "Lender"), as assignee, and originally filed with the United States Patent and Trademark Office (the "PTO") on April 27, 2001 at Reel 2285, Frame 0048 of the Trademark Record as an assignment, and re-filed with the PTO on August 28, 2001 at Reel 2359, Frame 0575 of the Trademark Record in a corrective filing as a security interest, the Lender became the holder of a security interest and conditional assignment in and to all of HDI's right, title and interest in certain United States trademarks; trademark registrations, trademark applications, patents and other intangible assets more particularly described on Exhibit A attached hereto (the "Collateral"); and

WHEREAS, the obligations secured by the Security Document have been paid in full and the Lender no longer claims a security or any other interest in the Collateral under the Security Document or otherwise.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender hereby expressly releases and discharges its security interest in and to the Collateral and reassigns, without representation, warranty or recourse, to HDI all of the Lender's right, title and interest in and to the Collateral.




