Miller ("Miller") ownership of United States Trademark Registration No. 1,152,497 (issued on February 3, 1981) for the mark MICHAEL JORDAN for certain goods in International Class 25 together with the good will symbolized thereby and together with any other rights Miller may have had to the said mark in other countries (hereinafter referred to the "Registered Mark"); and

WHEREAS, NIKE, Inc., an Oregon corporation, having a place of business in Beaverton, Oregon ("Assignee"), desires to acquire the entire right, title and interest in, to and under the Registered Mark;

NOW, THEREFORE, for and in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, said Assignor does hereby sell, assign, transfer and set over to said Assignee all its right, title and interest in, to and under the Registered Mark, together with the goodwill of the business symbolized by the Registered Mark, together with all rights and privileges granted and secured thereby, including the right to sue and recover for any past infringement and together with any other rights Assignor obtained from Miller, said rights to be held and enjoyed by said Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by said Assignor if this Assignment and sale had not been made.

AND, Assignor further acknowledges and agrees that this assignment in no way alters or amends any agreement between Assignor and Assignee, it being understood that Assignor obtained the Registered Mark as part of a settlement of an opposition for purposes of assigning the Registered Mark to Assignee.

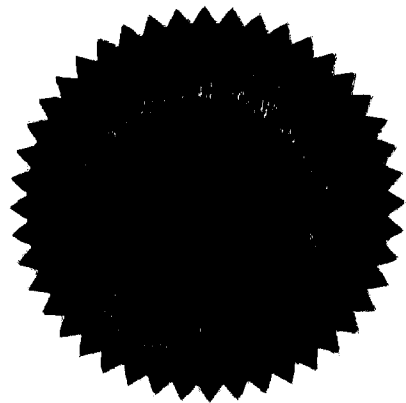
