**BILL OF SALE**

2. Assumption Of Liabilities. Buyer acknowledges and agrees that Buyer and any companies that Buyer is affiliated with (i) shall not become a successor in interest to NACM or the Company and (ii) shall not assume or become liable or responsible for any debts, claims, fines, obligations, or liabilities of NACM and/or Company of any nature whatsoever or relating to or arising in connection with the Company's business or properties, whether liquidated or unliquidated, known or unknown, fixed or contingent, arising by operation of law or otherwise.

3. Miscellaneous. This Bill of Sale shall inure to the benefit of and be binding upon Buyer and NACM and their respective successors and assigns, but shall not create any right of subrogation or other right on the part of any other person. This Bill of Sale cannot be amended, waived or terminated except by a writing signed by both NACM and Buyer. From time to time after the date hereof, upon the request of Buyer, NACM shall execute, deliver and acknowledge all such further instruments of transfer and conveyance and do and perform all such other acts and things as Buyer may reasonable request to more effectively transfer the Transferred Assets to Buyer and to put Buyer in possession of any of the Transferred Assets.
