APPOINTMENT OF SUCCESSOR ADMINISTRATIVE TRUSTEE
OF
THE STAD TRUST

WHEREAS, Severyn Ashkenazy and Arnold Ashkenazy were appointed as Administrative Trustees of The STAD Trust (the "Trust") pursuant to Section A of Article Five of the instrument of trust, dated August 28, 1979, and resigned as Administrative Trustees of the Trust, effective January 1, 1996; and

WHEREAS, Thomas Lausch is named as successor Administrative Trustee of the Trust in Section A of Article Five of said instrument of trust, and was deceased prior to the January 1, 1996, resignation of Severyn Ashkenazy and Arnold Ashkenazy, as Administrative Trustees; and

WHEREAS, no other successor Administrative Trustee of the Trust is named in said instrument of trust; and

WHEREAS, Section B of Article Five of said instrument of trust empowers the income beneficiaries to appoint a new Administrative Trustee of the Trust when there is no qualified and acting Administrative Trustee and no successor Administrative Trustee is named who is then living;

WHEREAS, Adrian Ashkenazy and Stefan Ashkenazy, each being 18 years of age or older, as the income beneficiaries of the Trust, appointed Manuel Jablonski as successor Administrative Trustee, effective January 1, 1996, pursuant to Section B of Article Five of said instrument of trust;

WHEREAS, Manuel Jablonski resigned as Administrative Trustee of the Trust, effective August 15, 1996, and Severyn Ashkenazy was appointed by said income beneficiaries as the sole Administrative Trustee, effective August 15, 1996;

WHEREAS, Severyn Ashkenazy resigned as Administrative Trustee of the Trust, effective February 1, 1997; and Ilan Avissar was appointed by said income beneficiaries as the sole Administrative Trustee, effective February 1, 1997;

WHEREAS, Ilan Avissar resigned as Administrative Trustee of the Trust, effective November 28, 2001, and Peter Benassi was appointed by said income beneficiaries as the sole Administrative Trustee, effective November 28, 2001; and

WHEREAS, Peter Benassi has resigned as Administrative Trustee of the Trust, effective August 1, 2002;


WHEREAS, Adrian Ashkenazy and Stefan Ashkenazy are the present income beneficiaries of the Trust; and

WHEREAS, Iga Pioro is over 18 years of age and is qualified and willing to act as successor Administrative Trustee of The STAD Trust;

NOW, THEREFORE, pursuant to Section B of Article Five of the instrument of trust of the Trust, Adrian Ashkenazy and Stefan Ashkenazy, as the present income beneficiaries, hereby appoint Iga Pioro as the successor Administrative Trustee of the Trust, effective August 1, 2002.
