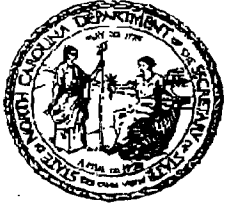

We, the undersigned, natural persons of the age of eighteen (18) years or more, do hereby associate ourselves into a business corporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act, and the several amendments thereto, and to that end to hereby set forth:

1. The name of the corporation is SAS Institute Inc.
2. The period of duration of the corporation shall be perpetual.
3. The purpose for which the corporation is organized is to engage in the business of developing, distributing and maintaining computer software and related activities, and to engage in any other lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.
4. The aggregate number of shares which the corporation shall have authority to issue is One Hundred Thousand (100,000) shares of common stock with a par value of One Dollar (\$1.00) per share.
5. The minimum amount of consideration for its shares, to be received by the corporation before it shall commence business, is One Hundred Dollars (\$100.00).
6. The address of the initial registered office of the corporation is 2143 Ridge Road, Raleigh, Wake County, North Carolina, and the name of the initial registered agent at such address is James H. Goodnight.

7. The number of directors of the corporation may be fixed by the by-laws, but shall not be less than three (3).

8. The number of directors constituting the initial Board of Directors shall be four (4), and the names and addresses of the persons who are to serve as directors until the first meeting of shareholders or until their successors are elected and qualified are:

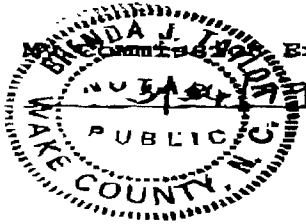


