ASSIGNMENT

This Assignment is made and entered into as of the 11th day of July, 1988, by and between TRINITY PAPER AND PLASTICS CORPORATION, ("Trinity"), a Delaware corporation formerly known as JHF Corporation ("JHF") and having a place of business at 555 Fifth Avenue, New York, New York and Manufacturers Hanover Commercial Corporation, a New York corporation, having a place of business at 270 Park Avenue, New York, New York 10017 (hereinafter "MHCC")

WHEREAS, as security for a promissory note issued by MHCC, JHF assigned to MHCC interest in the registered trademarks listed in Schedule A (the "Trademarks");

WHEREAS, it was agreed that MHCC cease to have an interest in the Trademarks upon the payment and performance in full of all obligations by JHF;

WHEREAS, Trinity has performed its obligations and made its payments such that MHCC and Trinity are now desirous of terminating the assignments to MHCC;

NOW THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt of which is hereby acknowledged, MHCC and Trinity agree as follows:

1. MHCC does hereby assign and convey to Trinity all right title and interest it owns in the Trademarks, together with the good will of the business symbolized by said marks.

2. MHCC agrees to execute and deliver to Trinity any further documentation or papers, and take all such other action, as is necessary to carry out the intent or purpose of this Agreement.

3. The parties agree that this Assignment replaces any previous agreements and arrangements, whether written or oral, between Trinity and MHCC with respect to the Trademarks.

4. The parties agree that the validity, interpretation and enforcement of this Assignment, and all rights hereunder, shall be governed by the laws of the State of New York.
