

Cubby K
October 10, 2001**


The Alliance for Early Childhood Professionals has been the fiscal agent for the development of the icon, "Cubby K," as part of the work of the Early Childcare and Education Commission. The intention has been to have this icon support the ongoing work and goals of the Commission, and the organization, Ready 4 K, has taken on that role. The transfer of these items is commensurate with that intention.

1. Trademarks for Cubby K in all major categories.
2. URLs for Cubby K, including: (a) CubbyK.com/net/org (b)ready4k.com/net/org (c) readyfork.com/net/org (d)championsforchildren.com/net/org (e) kreadyteddy.com/net/org
3. Cubby K costume, audiovisuals, and books.
4. Continued work with Fallon Minneapolis.

In return for these transfers, Ready 4 K agrees that 50% of any future net income generated by the use of the icon commercially will be directed to the support of issues pertaining to the workforce in early child care and education.

Relating to Cubby K, there is an existing contract between the Alliance and Anne Nicolai that stipulates 5% of revenue from Cubby K net income will be paid to Ms. Nicolai. This current transfer agreement does not deal with that issue.
