RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated ^{September} August 3, 2002 (this "Release") is made by Wells Fargo Bank Minnesota (formerly Northwest Bank Minnesota), a National Banking association with a place of business at Sixth Street and Marquette Avenue, Minneapolis, MN 55479 acting in its capacity as Secured Party and Agent for certain Banks (in such capacity, the "Secured Party") under an Agreement dated September 8, 1999, and recorded on December 6, 1999 in the records of the United States Patent and Trademark Office at Trademark Reel 2013, Frame 0141 (the "Trademark Agreement"), among Hespeler Hockey Holding, Inc.
