ASSIGNMENT OF TRADEMARKS

Except as specifically set forth in the Secured Party General Conveyance and Bill of Sale executed even date herewith, (a) Assignor makes no warranty or representation with respect to the Trademarks, and (b) Assignee acknowledges by its acceptance hereof that it is accepting all of Borrowers' rights in and to the Trademarks "as is," "where is" and without implied or expressed warranty.
