**LIMITED RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release") is made as of August 31, 2002, by COMERICA BANK - CALIFORNIA, a California chartered bank and successor by merger to Imperial Bank, with an address at 695 Town Center Drive, Costa Mesa, California 92626 ("Secured Party"), in favor of SYNBIOTICS CORPORATION, a California corporation with an address at 11011 Via Frontera, San Diego, California 92127 ("Company").

W I T N E S S E T H:

WHEREAS, Company executed that certain Commercial Security Agreement dated April 12, 2000, as amended as of April 18, 2000, November 14, 2000 and January 25, 2002 ("Security Agreement"), pursuant to which Company granted a security interest to Secured Party in, among other things, certain intellectual property owned by Company, and

WHEREAS, Company executed that certain Trademark Security Agreement, dated April 12, 2000 ("Trademark Agreement"), pursuant to which Company granted a security interest to Secured Party in certain trademarks owned by Company; and

WHEREAS, said Trademark Agreement was filed with the Assignment Branch of the United States Patent and Trademark Office on July 2, 2001; and

WHEREAS, Secured Party has agreed to release all its rights, including but not limited to security interests, assignments, and liens, in the trademarks, trademark applications and registrations listed on the attached Schedule A (the "Released Collateral"), and to reconvey any and all rights it may have in the Released Collateral to Company:

NOW, THEREFORE, for good and value consideration, receipt of which is hereby acknowledged, the Parties agree as follows:

1. Secured Party releases, without recourse or warranty, and reconveys to Company, all its right, title, claim and interest in and to the Released Collateral, and any and all rights corresponding thereto, including but not limited to, security interests, assignments, and liens.
2. Each of the Security Agreement and Trademark Agreement remains in effect with respect to all collateral secured thereby, other than the Released Collateral.
3. Secured Party hereby represents and warrants that it has not transferred any rights in the Released Collateral to any other party.
4. This Release may be executed in two counterparts, each of which shall be deemed to be an original and all such counterparts shall constitute but one and the same instrument.
