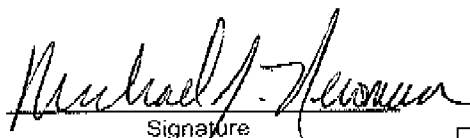

This Certificate of Conversion to Limited Liability Company is being duly executed and filed by James C. Fontana, in such person's capacity as Corporate Secretary of Wang Government Services, Inc., a Delaware corporation (the "Corporation"), and an authorized person, to convert the Corporation to a Delaware limited liability company under the General Corporation Law of the State of Delaware (8 Del. C. § 101, et seq.) (the "GCL") and the Delaware Limited Liability Company Act (6 Del. C. § 18-10, et seq.).

1. The name of the Corporation under which it was originally incorporated in the State of Delaware was Honeywell Federal Systems Inc., pursuant to a Certificate of Incorporation filed on December 9, 1986; with its name subsequently changed to HFS Inc. pursuant to a Certificate of Amendment to Certificate of Incorporation filed on October 1, 1990; with its name subsequently changed to Wang Federal, Inc. pursuant to a Certificate of Amendment to Certificate of Incorporation filed on May 10, 1995; and its name as of immediately prior to the filing of this Certificate of Conversion to Limited Liability Company being Wang Government Services, Inc. pursuant to a Certificate of Amendment to Certificate of Incorporation filed on April 25, 1997. The name of the Corporation has not been changed since the Corporation's last Certificate of Amendment to Certificate of Incorporation dated April 25, 1997.

2. The Corporation was originally incorporated in the State of Delaware, by filing of its original certificate of incorporation with the Secretary of State of the State of Delaware on December 9, 1986, and the jurisdiction of the Corporation's incorporation has not been changed since such date and remains the State of Delaware as of immediately prior to the filing of this Certificate of Conversion to Limited Liability Company.

3. The name of the limited liability company into which the Corporation shall be converted as set forth in the limited liability company's certificate of formation shall be Getronics Government Solutions, L.L.C.


4. The conversion of the Corporation into a limited liability company has been approved in accordance with the provisions of Section 266 of the GCL.

5. The conversion of the Corporation into a limited liability company shall be effective upon the filing of this Certificate of Conversion to Limited Liability Company and a certificate of formation of the limited liability company with the Secretary of State of the State of Delaware.
