1. Article I is hereby amended to read as follows:

ARTICLE I - NAME

The name of this Corporation is PSCU FINANCIAL SERVICES, INC.

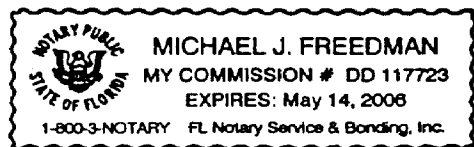
