

**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks is granted on this 5th day of December 2002, by U.S. Bank National Association, f/k/a First Trust National Association, a national association with offices at 180 East Fifth Street, St. Paul, Minnesota 55101, as trustee for the holders of the notes (the "Secured Party") to Great American Cookie Company, Inc., a Delaware corporation, with offices at 4685 Fredrick Drive, S.W., Atlanta, Georgia 30336 (the "Borrower"), as follows:

WHEREAS, Borrower and Secured Party entered into the Trademark Security Agreement, dated as of December 10, 1993, the ("Trademark Security Agreement") which was recorded with the U.S. Patent and Trademark Office on December 21, 1993 at Reel/Frame 1083/0235, et seq.;

WHEREAS, pursuant to the Trademark Security Agreement, for the benefit of the Secured Party and for the ratable benefit of the Securityholders (as such term is defined in the Trademark Security Agreement) Borrower granted a continuing security interest in all of the Borrower's right, title, and interest in the Trademarks (as such term is defined in the Trademark Security Agreement), among other collateral, including but not limited to the trademarks set forth on Schedule A hereto, in order to secure the due and punctual payment and performance of all the Secured Obligations (as such term is defined in the Trademark Security Agreement) (the "Security Interest"); and

WHEREAS, the Borrower has performed all of the Secured Obligations contained in the Trademark Security Agreement;

WHEREAS, the Secured Party agrees to release, restore, and reassign all right, title and interest in and to the Trademarks to the Borrower and to dissolve the Security Interest and any and all liens and encumbrances respecting the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby releases, discharges, quit claims, and relinquishes any and all right, title and interest in and to the Trademarks.
