WHEREAS, ASSIGNEE is desirous of acquiring said Marks, including but not limited to any applications thereof, and the goodwill of the business associated with said Marks;



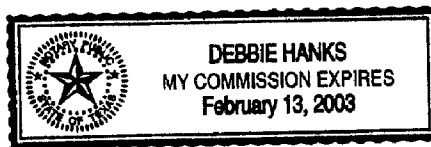
