ASSIGNMENT OF INTELLECTUAL PROPERTY

This Assignment of Intellectual Property (this "Assignment"), dated December 3, 2002 by and between The Fairchild Corporation, a Delaware Corporation (the "Parent"), Fairchild Holding Corp., a Delaware corporation and an indirect, wholly owned subsidiary of the Parent ("Fairchild Holding") and Sheepdog, Inc., a Delaware corporation and an indirect, wholly owned subsidiary of the Parent (together with the Parent, Fairchild Holding and the subsidiaries of the Parent set forth on Schedule 1.125 of the Acquisition Agreement, as defined below, collectively, the "Assignors") and Huck Patents, Inc., a Delaware corporation ("Assignee").

RECITALS

WHEREAS, pursuant to the Acquisition Agreement, dated as of July 16, 2002 (the "Acquisition Agreement"), among Assignors and Alcoa Inc., a Pennsylvania corporation ("Alcoa"), Alcoa desires Assignee to acquire from the Assignors all of Assignors' right, title and interest in and to all of the Fastener Business Intellectual Property (other than the Fastener Business Assets owned or held by the Transferred Fastener Subsidiaries), including the Fastener Business Intellectual Property listed on Exhibit A hereto; and

WHEREAS, pursuant to Section 2.2 of the Acquisition Agreement, Assignors desire to assign to Assignee, and Assignee desires to acquire, all of Assignors' right, title, and interest in and to all of the Fastener Business Intellectual Property (other than the Fastener Business Assets owned or held by the Transferred Fastener Subsidiaries), including the Fastener Business Intellectual Property listed on Exhibit A hereto, together with the goodwill pertaining thereto (collectively, the "Assigned Intellectual Property").

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing premises, the covenants and agreements contained in the Acquisition Agreement and in this Assignment, and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, to implement the assignments of the Fastener Business Intellectual Property required by the Acquisition Agreement, and intending to be legally bound, Assignors hereby agree as follows:

1. Capitalized terms used but not defined in this Assignment shall have the meanings ascribed to such terms in the Acquisition Agreement.

2. Assignors do hereby sell, transfer, convey, assign, grant, set over and deliver to Assignee, and Assignee hereby accepts, all of Assignors' right, title, and interest in and to the Assigned Intellectual Property, free and clear of all Liens (other than Permitted Exceptions), the same to be held by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns, designees, nominees and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignors if this Assignment and sale had not been made, together with (i) all causes of action (in law or equity), claims, demands and any other rights for, or arising from, any past, present or future infringement, of the Assigned Intellectual Property, (ii) the right to sue for and collect any

damages for the use and benefit of Assignee and Assignee's successors, assigns, designees, nominees and other legal representatives, and (iii) to the extent that any trademark or service mark applications included in the Assigned Intellectual Property are filed on the basis of Assignors' "intent to-use" such trademarks or service marks, the portion of the business to which those trademarks or service marks apply (which business is ongoing and existing).

3. As may be requested by Assignee or its designee or other legal representative from time to time after the date hereof, Assignors agree to assist Assignee, or Assignee's successors, assigns, designees, nominees or other legal representatives, in a commercially reasonable manner, without further consideration, to (i) evidence, record, and perfect the assignment of the Assigned Intellectual Property and (ii) secure Assignee's rights in the Assigned Intellectual Property, including, but not limited to, the execution, delivery and filing of all applications, specifications, oaths, assignments, powers-of-attorney, and similar instruments that Assignee deems necessary to assign and convey to Assignee, or Assignee's successors, assigns, designees, nominees or other legal representatives, all right, title and interest in and to the Assigned Intellectual Property.

4. Assignors hereby authorize and request the Commissioner of the United States Patent and Trademark Office and all other applicable bureaus or offices whose duty it is to issue, certify, record and/or assign registrations or applications for service marks, trademarks, patents, copyrights, Internet domain names or other forms of intellectual property protection, to issue, certify record and/or assign as appropriate, the same to Assignee and Assignee's successors, assigns, designees, nominees and other legal representatives in accordance with the terms of this Assignment.

5. In the event of a conflict between the terms of this Assignment with any agreement entered into or other document filed for the purposes of recording the assignments contemplated herein with applicable bureaus or offices whose duty it is to issue, certify, record and/or assign registrations or applications for service marks, trademarks, patents, copyrights, Internet domain names or other forms of intellectual property protection (such agreement or document, the "Local Filing"), the provisions of this Assignment shall control and prevail. Any such Local Filing is merely for recording the assignments contemplated herein and does not alter, modify or supercede the terms and conditions of this Assignment. Notwithstanding the foregoing, to the extent any provision of any Local Filing conflicts with this Assignment and is required to effectuate the recording of the Local Filing under the laws of the jurisdiction where the Local Filing is to be recorded, such conflicting provision shall control and prevail for the purposes of recording the Local Filing in the applicable jurisdiction.

6. This Assignment does not limit any of the provisions of the Acquisition Agreement. This Assignment is subject to the terms and conditions of the Acquisition Agreement. To the extent that any provision of this Assignment is inconsistent with the Acquisition Agreement, the provisions of the Acquisition Agreement shall control.

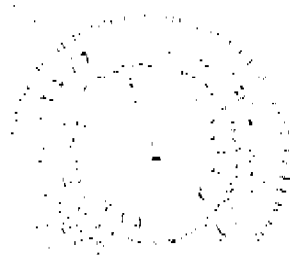

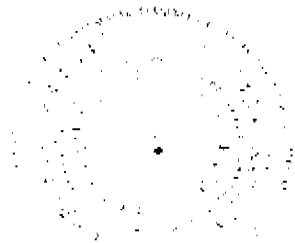
