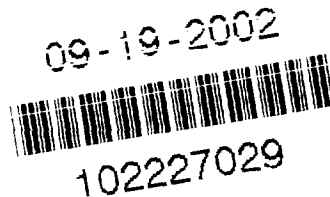

TRANSFER STATEMENT
