Perluzzo, Martino Perluzzo, 1010 Sherbrooke St. West, Suite 2350, Montreal, Quebec, H3A 2R7, as the firm to whom any notice relating to the Trade-marks may be sent and upon whom service of any proceedings in respect thereof may be made with the same effect as if they had been given to or served upon the Purchaser itself.


