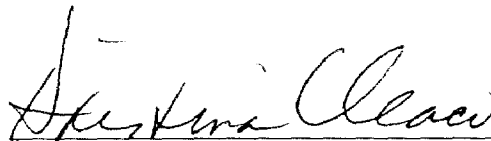

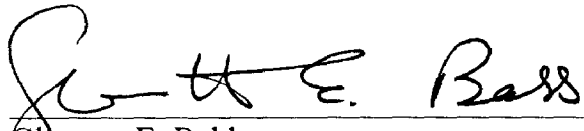
1. They are the Vice President and Assistant Secretary, respectively, of F. D. Titus and Son Inc., a California Corporation.

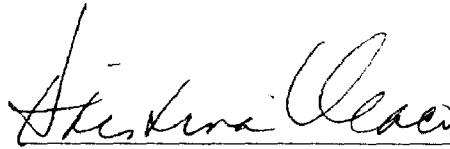

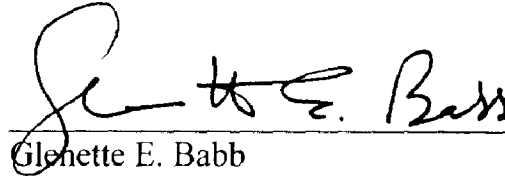
