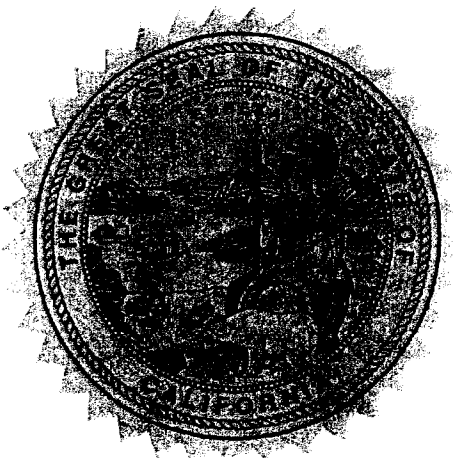

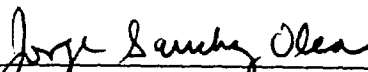

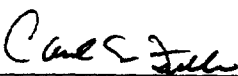
1. They are the President and Secretary, respectively, of CJT Technologies, a California corporation.
