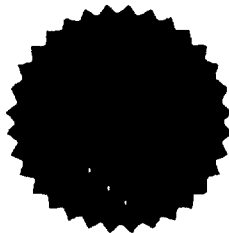

KBF ACQUISITION CORP., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify as follows:

**FIRST:** Resolutions setting forth a proposed amendment to the Certificate of Incorporation of the Corporation, declaring said amendment to be advisable, were duly adopted by a resolution of the board of directors dated September 15, 2002 in accordance with Section 141 of the General Corporation Law of the State of Delaware.

**SECOND:** The Corporation has not received any payment for any of its stock and the amendment has been duly adopted by a majority of the directors of the Corporation in accordance with Section 241 of the General Corporation Law of the State of Delaware.

**THIRD:** Said amendment would amend the Certificate of Incorporation of the Corporation by deleting Article FIRST and substituting in lieu thereof the following new Article FIRST:

"FIRST. The name of the corporation is "Kathryn Beich, Inc." (the "Corporation")."

**FOURTH:** Said amendment would amend the Certificate of Incorporation of the Corporation by deleting Article FOURTH and substituting in lieu thereof the following new Article FOURTH:

"FOURTH: The aggregate number of shares which the Corporation shall have the authority to issue is Two Million (2,000,000) shares of common stock of a par value of \$0.01 each."
