For One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, FONIX CORPORATION, a Delaware corporation having a principal place of business at 1225 Eagle Gate Tower, 60 East South Temple Street, Salt Lake City, Utah 84111 (the "Assignor"), hereby sells, assigns and transfers to LERNOUT & HAUSPIE SPEECH PRODUCTS N.V., a Belgian corporation having a place of business at Flanders Language Valley 50, B-8900 Ieper, Belgium, and its successors and assigns (the "Assignee"), Assignor's entire right, title and interest in and to all of the servicemarks/trademarks, applications for trademark registration and trademark registrations owned by Fonix/ASI Corporation ("ASI") immediately prior to the merger of ASI with and into Assignor (the "Merger"), effective as of the date hereof, and now owed by Assignor as a result of the Merger, including, but not limited to, those servicemarks/trademarks, applications for trademark registrations and trademark registrations set forth on Exhibit A attached hereto, together with the goodwill of the business symbolized or represented by such servicemarks/trademarks, applications for trademark registration and registrations thereof.
