ASSIGNMENT OF TRADEMARK ASSETS

THIS ASSIGNMENT is dated as of the 6th day of September, 2002, and is made from Paper-Pak Products, Inc., a Delaware corporation, ("Assignor") on the one hand, to USPP Holdco, Inc., a Delaware corporation ("Assignee") on the other hand.

WITNESSETH

WHEREAS, pursuant to the Asset Purchase Agreement by and among the Assignor, as Seller, and the Assignee and Paper-Pak Europe Limited, as Purchasers, dated as of August 12, 2002, Assignee is desirous of acquiring, and Assignor is desirous of transferring to Assignee, certain trademark assets and the goodwill associated with such trademark assets;

NOW, THEREFORE, in consideration of the premises and the mutual covenants hereinafter set forth, the parties agree as follows:

1. Trademark Assets.

1.1 Assignor has adopted, used in commerce and applied for and/or acquired certain registrations and rights in the trademark assets, set forth in Schedule A attached hereto (the "Trademark Assets").

2. Assignment of Trademark Assets.

2.1 Assignor assigns to Assignee all rights, title and interests in and to the Trademark Assets, the goodwill of the business symbolized by the Trademark Assets, all registrations and applications for registration thereof, all rights of action accrued and to accrue under and by virtue thereof, including the right to sue and recover for past infringement of said Trademark Assets, and all records and files relating to said Trademark Assets. This Assignment of Trademark Assets will be governed by the laws of the State of New York without regard to its conflicts of laws principles.

2.2 Assignor shall sign all documents, and, at Assignee's sole cost and expense: (i) provide all testimony reasonably requested by Assignee and (ii) do all lawful things reasonably requested of them by Assignee, as the foregoing are necessary to carry out and fulfill the purposes and intent of this Agreement.

2.3 Assignor hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.

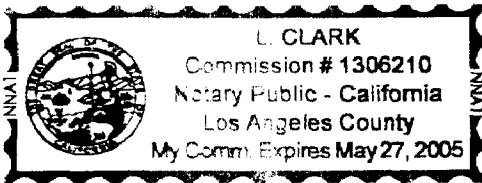
