RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of September 16, 2002, by Guaranty Business Credit Corporation ("GBCC"), the secured party under that certain Security Agreement referred to below.

W I T N E S S E T H:

WHEREAS, QuorTech Global Solutions, Inc., a Delaware corporation ("Borrower"), executed that Grant of Security Interest – Trademarks dated as of April 29, 2002 (the "Security Agreement") pursuant to which Borrower granted a security interest to GBCC in certain trademarks of Borrower; and

WHEREAS, said Security Agreement was recorded with the Assignment Branch of the United States Trademark Office on May 15, 2002 at Reel 002505, Frame 0502; and

WHEREAS, the registration number provided by Borrower to GBCC for the trademark TSG was not the correct registration number;

WHEREAS, GBCC has agreed to release all its rights under such Security Agreement, including, without limitation, in the trademarks and applications therefor identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to the person legally entitled thereto.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, receipt of which is hereby acknowledged, GBCC hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of GBCC's right, title and interest in and to the Released Collateral, releases all other rights it may have under said Security Agreement with respect to the Released Collateral and cancels such Security Agreement in its entirety, all without warranty or representation of any kind.


