## CONFIRMATORY TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made by CFX, Inc., a Florida corporation ("Assignor") to Juan Mejia ("Assignee") for \$2,500.00.

WHEREAS, Assignor is the owner of the trademark "SELECTA FARMS" Reg. No. 1,916,689 and the goodwill of the business symbolized thereby (the "Trademark"); and

WHEREAS, the Assignor and certain of its sister subsidiaries, together with their parent, U.S.A. Floral Products, Inc. (collectively, the "Debtors") filed a voluntary petition for relief under Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code") in the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court"), and the Assignor continues to operate as a debtor and debtor-in-possession pursuant to §§ 1107 and 1108 of the Bankruptcy Code; and

WHEREAS, the Debtors filed a Motion (the "Motion") for entry of an Order authorizing them to sell to the Assignee the Trademark, and the Bankruptcy Court approved said Motion by Order entered on or about August 6, 2001; and

WHEREAS, the Trademark is subject to the first lien of the agent for the Debtors' prepetition lenders (the "Agent"), and the Agent has agreed to release its lien on the Trademark provided that its lien attach to proceeds of the sale thereof;

WHEREAS, the Debtors agreed to sell the Trademark to Assignee for the amount of \$2,500.00, and the Assignor has agreed to remit that amount to the Debtors; and

WHEREAS, pursuant to the terms of the Motion, the Debtors agreed to provide and execute such other agreements and documents as may be reasonably required by Assignee to effect the formal transfer and recordation of the sale, transfer and assignment of the Trademark.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Assignor affirms that it has sold, assigned and transferred, and by this document does *nunc pro tunc* sell, assign, and transfer, as of August 6, 2001, to Assignee, its successors and assigns forever, all right, title and interest Assignor has in and to the Trademark, the registrations and applications therefor together with the goodwill of the Assignor's business symbolized thereby, the same to be held and enjoyed by Assignee, its successors and assigns forever, as fully and entirely as the same could have been held and enjoyed by Assignor had this Assignment not been made.

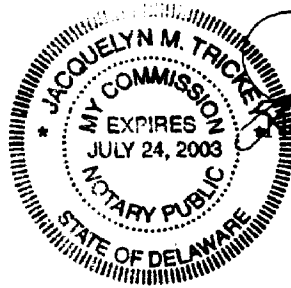
