
RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST dated September 16, 2002 ("Release") is made by National City Bank of Pennsylvania, a Pennsylvania corporation (the "Secured Party") under the Trademark Security Agreement dated November 13, 2001, as amended or modified, and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 2417, Frame 0329 (the "Agreement"), among BJK Holdings, Inc. (the "Debtor") and the Secured Party, as Agent for the benefit of all Lenders under the Credit Agreement dated as of November 13, 2001.
