## TRADEMARK ASSIGNMENT

Trademark Assignment made this 31st day of December, 2001.

WHEREAS, Fairmount Custom Products, Inc., an Ohio corporation formerly known as Fairmount Abrasives, Inc. (the "Company"), acquired the trademark set forth on Schedule A to this Trademark Assignment (hereinafter the "Trademark") which has been used exclusively by Stan Blast Abrasives, L.L.C., a Delaware limited liability company ("Stan Blast"), of which the Company is the sole member;

WHEREAS, the Company is desirous of transferring all of its interest in and to the Trademark to Minerals and Minerals is desirous of acquiring such interest;

NOW, THEREFORE, for good and valuable consideration expressed in the Purchase Agreement, receipt of such consideration being hereby acknowledged by the Company, the Company does hereby assign and transfer to Minerals, without restriction, all of the Company's right, title, and interest, worldwide, in and to the Trademark together with the good will of the business symbolized by the Trademark, registrations thereof, and applications for registration thereof. Without limitation of the generality of the interest conveyed, the conveyance includes (a) all of the Company's right, title, and interest (both statutory and common law) in and to the Trademark; (b) any and all registrations and applications for registration thereof in the United States and throughout the world; and (c) all trademark enforcement rights and remedies which the Company may now have with respect to the Trademark including the Company's standing to assert civil, criminal, and administrative remedies of all kinds and the Company's right to damages for past infringement thereof.
