CORPORATE ASSIGNMENT

The Assignor vests in Assignee like exclusive title in and to all such other Trademarks and Trademark Applications. The Assignor will execute or direct those under their direct or indirect control to execute and deliver to Assignee any documents which may be requested by Assignee to carry out the terms of this Assignment; and

The Commissioner of Patents and Trademarks of the United States is authorized and requested to issue any Trademark registration of the United States to Assignee. The Assignor also authorizes and requests the equivalent authorities in foreign countries to issue the registrations of foreign countries to Assignee.

IN WITNESS WHEREOF, Assignor has caused this Assignment to be executed by its duly authorized officer effective as of the 7th day of August, 2002.
