Assignor hereby agrees to execute any documents and do any other acts as may be reasonably required to further effectuate the assignment of the Marks to Assignee, and Assignor appoints Luce, Forward, Hamilton & Scripps, LLP as Assignor's attorney-in-fact, with full power of substitution and delegation, to execute any and all such documents and do any and all such other acts in order to effectuate the assignment of the Marks to Assignee, and record the assignment with the U.S. Patent and Trademark Office or other relevant governmental authority.
