WHEREAS Assignor is the owner of the trademark registrations set forth in Exhibit 1 and incorporated herein by reference;


WHEREAS, Assignor is the owner of the pending intent-to-use trademark applications set forth in Exhibit 2 and incorporated herein by reference;



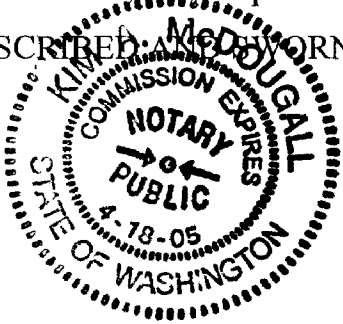

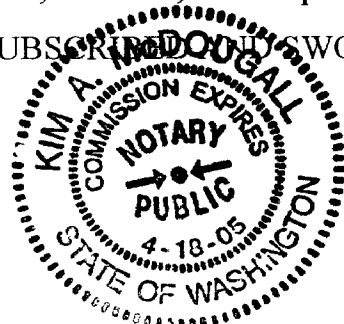
