

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF



CHILDRENS MEMORIAL HOSPITAL OMAHA, NEBRASKA

Pursuant to the provisions of the Nebraska Nonprofit Corporation Act, the undersigned nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Childrens Memorial Hospital Omaha, Nebraska.
- 2. There are no members of the corporation.
- 3. The following amendment to the Articles of Incorporation was adopted by a majority of the members of the Board of Trustees at a meeting held on May 21, 1996.
- 4. That Article II of the Articles of Incorporation shall be deleted in its entirety and a new Article II shall be adopted as follows:

ARTICLE II

The name of said charitable corporation shall be Children's Hospital and its location shall be in the City of Omaha, Douglas County, Nebraska. It shall have perpetual existence.
