ARTICLES OF AMENDMENT of the Articles of Incorporation of VOPAK DISTRIBUTION AMERICAS CORPORATION. (the "Corporation") are herein executed by said Corporation, pursuant to the provisions of RCW 23B.10.020 and 23B.10.060, as follows:

FIRST: The name of the Corporation is VOPAK DISTRIBUTION AMERICAS CORPORATION.

SECOND: Article I of the Articles of Incorporation is amended to read as follows:

The name of the corporation is UNIVAR NORTH AMERICA CORPORATION.

THIRD: This amendment does not provide for an exchange, reclassification or cancellation of issued shares.
