

ASSIGNMENT OF TRADE MARKS AND NAMES

THIS ASSIGNMENT is made the 31st day of July 2002

BETWEEN

(1) JL & COMPANY LIMITED, whose registered office is at Westminster Works, Oliver Street, Northampton, NN2 7JL ("the Assignor")

and

(2) EDWARD GREEN & COMPANY LIMITED, whose registered office is at 74-76 Cowper Street, Northampton NN1 3QR ("the Assignee")

RECITALS

- (a) The Assignor is the registered proprietor of the Trade Marks.
- (b) The Assignor has agreed with the Assignee to sell, and the Assignee has agreed to buy, the Trade Marks and any associated goodwill and the Assignor's right (if any) to the Names all for the sum of £1 subject to the terms and conditions set out below.

NOW THEREFORE

1 In this Assignment the following terms shall have the following meanings:

1.1 "Trade Marks"

means the registered marks short particulars of which are set out in the Schedule attached hereto.

1.2 "Names"

means any name, other than Esquire, licensed to the Assignee by Clause 3 of the written agreement between the Assignor and Assignee dated 15 April 1997 ("the Agreement").

2 Pursuant to the Agreement and upon the Assignee warranting that it has fully complied with the terms of Clause 2 of the Agreement, and in consideration of the sum of £1 paid by the Assignee to the Assignor (the receipt of which the Assignor acknowledges), the Assignor as beneficial owner hereby assigns to the Assignee absolutely together with all the Assignor's rights and interests in respect of them and any associated goodwill:

2.1 the Trade Marks;

2.2 the exclusive right (so far as the Assignor can confer it) to the Names.

3 The Assignor agrees with the Assignee, at the direction and expense of the Assignee, and upon payment by the Assignee of all costs and expenses of the Assignor, to execute any further document which the Assignee may reasonably require to enable it to become registered by UK and foreign Trade Mark Registries as the proprietor to the Trade Marks.

4 This Assignment shall be governed and construed in accordance with the laws of England and the parties hereto submit to the non-exclusive jurisdiction of the English Courts.
