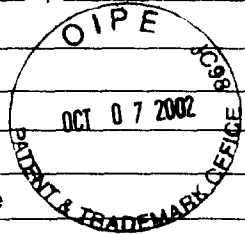

SECOND: That the Corporation owns all of the outstanding shares of each class of the capital stock of First Data Information Management Group Inc., a Delaware corporation.

THIRD: That the Corporation, by the following resolutions of its Board of Directors, duly adopted on the 14th day of July, 1999, determined to merge into itself First Data Information Management Group Inc. on the conditions set forth in such resolutions:

FURTHER RESOLVED, that any officer of the Corporation be and each of them hereby is authorized, empowered and directed, in the name and on behalf of the Corporation, to execute and deliver any and all documents, and to do or cause to be done any and all acts as such officer may deem necessary or appropriate to effect the transactions contemplated by these resolutions, all such acts, whether heretofore or hereafter performed, that are in conformity with the intent of these resolutions being hereby ratified, confirmed and approved.

FOURTH: That such resolutions and this certificate are intended to constitute a plan of liquidation of First Data Information Management Group Inc. for purposes of Section 332 of the Internal Revenue Code.
