Pursuant to Section 253 of the
General Corporation Law of the State of Delaware

JetFax, Inc. a corporation organized and existing under the General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY:

FIRST: That this corporation owns all of the outstanding shares of eFax.com, Inc. a corporation organized and existing under the General Corporation Law of the State of Delaware.

SECOND: That this corporation, by the following resolutions of its Board of Directors, adopted at a duly constituted meeting of the Board of Directors on the 8th day of January 1999, determined to merge eFax.com, Inc. into itself on the terms and conditions set forth in such resolutions:

RESOLVED, that eFax.com, Inc. be merged with and into the Corporation and that the Corporation be the surviving corporation in such merger;

FURTHER RESOLVED, that the merger shall become effective upon the date and time of the filing of a Certificate of Ownership and Merger with the Secretary of State of the State of Delaware;

FURTHER RESOLVED, that upon the effectiveness of the merger, the Corporation shall assume all of the liabilities and obligations of eFax.com, Inc.; and

FURTHER RESOLVED, that upon the effectiveness of the merger, the name of the Corporation shall be changed to "eFax.com, Inc." and Article One of the Certificate of Incorporation of the Corporation shall be amended to read as follows:
