TRADEMARKS ASSIGNMENT

This Trademarks Assignment (the "Assignment") is made as of June 13, 2002, by Compagnie Oris Industrie S.A., a France Joint Stock Company, with its principal place of business at 31-33 rue de la Federation 75015 PARIS, France ("Assignor") to Cis Bio International, a France corporation, with its principal place of business at RN 306 91400 Saclay, France ("Assignee").

Assignor desires to assign to Assignee, and Assignee desires to acquire from Assignor, all of Assignor's right, title and interest in and to the trademarks registrations set forth on Exhibit A hereto (the "Trademarks"), together with the goodwill of the business symbolized thereby.

NOW, THEREFORE, in consideration of the premises set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which and hereby acknowledged, the parties agree as follows:

1. **Assignment.** Assignor hereby grants, assigns and conveys to Assignee all of its right, title and interest in and to the Trademarks, together with the goodwill on the business symbolized hereby.

2. **Title.** Assignor hereby represents and warrants that it has no heretofore granted any license, right or privilege with regard to the Trademarks, or in any other way encumbered the same, and that it has the full right to convey, free of licenses and encumbrances, all right, title and interest in and to the Trademarks.

3. **Right to Sue Past Infringement.** Assignor also assigns to Assignee all claims for past damages by reason of past infringement or misappropriation of the Trademarks, with the right to sue for and collect same for its own use and behalf and for the use on behalf of Assignee's successors, assigns or other legal representatives.

4. **Cooperation.** Assignor agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by Assignee to effectuate more fully the transactions contemplated by this Assignment.

5 Binding Effect. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors and other legal representatives, and shall be binding upon Assignor, its successors, assigns and other legal representatives.
