ASSIGNMENT OF INTELLECTUAL PROPERTY

THIS ASSIGNMENT is made by SCHREIBER INTERNATIONAL, INC., a Delaware corporation located at 425 Pine Street, Green Bay, Wisconsin 54301 ("SII"), to SCHREIBER TECHNOLOGIES, INC., a Minnesota corporation located at 21150 Hamburg Avenue, Lakeville, Minnesota ("STI").

SII is the owner of all rights, title and interest in, to and under the trademarks and related trademark registrations set forth in Schedule A (the "Marks"); the United States patents and patent applications set forth in Schedule B (the "Patents"); and the confidential formulae, processes, technologies, formulations and other trade secrets set forth in Schedule C (the "Trade Secrets").

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, SII hereby transfers and assigns to STI, its successors and assigns, SII's entire rights, title and interest in, to and under:

(1) the Marks together with the goodwill of the business symbolized by the Marks, and together with the registrations of the Marks, along with the right to sue for and recover damages for past infringement of the Marks, and any rights held by SII in any country in any of the Marks along with the goodwill associated therewith, such that STI shall in all respects hold and enjoy any and all rights previously held and enjoyed by SII as owner of the Marks;

(2) the Patents, together with the applications and registrations of the Patents, along with any and all legal protection relating to the Patents and patent applications, and all rights and benefits under any applicable treaties or conventions relating to the Patents and patent applications, including the right to sue for and recover damages for past infringement of any of the Patents or patent applications; and

(3) The Trade Secrets, including the right to sue for and recover damages for past infringement of any of the Trade Secrets.

SII authorizes the Commissioner of Patents, or equivalent, to issue any and all legal protection to STI, and SII further authorizes STI, its successors and assigns, or anyone STI may properly designate, to apply for letters patent or similar legal protection, in its own name, in any and all foreign countries as may be applicable for the Patents or patent applications.

SII represents to STI, its successors and assigns, that SII has not and shall not execute any writings or do any acts whatsoever that conflict with this Assignment. SII and any successor, agent, representative, executor and/or administrator of SII, will at any time, upon request and without additional consideration, but at the expense of STI, its successors and assigns, execute any and all additional writings and do such additional acts as STI, its successors and assigns, may deem desirable to perfect and maintain its enjoyment of this Assignment and grant, and render any and all assistance in making application for and obtaining, maintaining and enforcing the rights granted herein in all countries.
