**RELEASE**

("CKE"), a Delaware corporation, having a place of business at 3916 State Street, Suite 300, Santa Barbara, California 93105, for the benefit of Roy Rogers Franchise Company, L.L.C., a Maryland limited liability company ("RRFC"), as follows:

WHEREAS, RRFC is the owner of U.S. Registration No. 1,447,946 for the mark FIXIN'S BAR® (the "Registration");

WHEREAS, BNP Paribas' predecessor in interest, Banque Paribas, had entered into a security agreement with CKE on July 15, 1997, and a security interest was mistakenly recorded against the Registration with the United States Patent and Trademark Office at Reel/Frame No. 1623/0453, listing Carl Karcher Enterprises, Inc., Summit Family Restaurants, Inc., Casa Bonita, Inc. and Hardee's Food Systems, Inc. as assignors; and

WHEREAS, Hardee's, prior to execution of such security agreement, had properly assigned all rights, title and interest in the Registration to RRFC's predecessor in interest, MRO Mid-Atlantic Corp.; and

WHEREAS, the parties wish to clear title to the Registration and to release the previously recorded security interest in and continuing lien on the Registration to the extent such interest existed.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby acknowledge that BNP Paribas never had a secured interest in and to the Registration, and to the extent such interest existed, BNP Paribas hereby releases the security interest in and continuing lien on all right, title and interest in the Registration and reassigns any and all such interests in the Registration to RRFC.

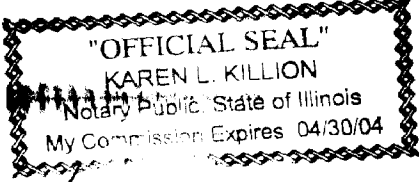

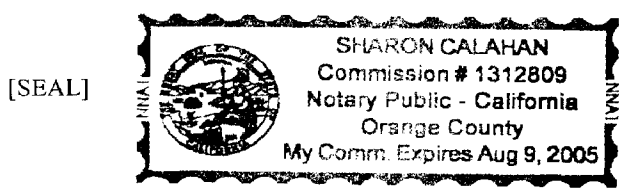
