ARTICLES OF AMENDMENT
OF
ARTICLES OF INCORPORATION
OF
DM ACQUISITION, INC.

- 1. The name of the corporation is DM Acquisition, Inc.
- 2. The following is the full text of the amendment to the Articles of Incorporation of DM Acquisition, Inc.:

RESOLVED, that Article 1 of the Articles of Incorporation is hereby amended in its entirety to read as follows:

"1. Name. The name of the Corporation shall be ASI DataMyte, Inc."

FURTHER RESOLVED, that Article 3 of the Articles of Incorporation is hereby amended in its entirety to read as follows:

"3. Authorized Shares. The aggregate number of shares that the Corporation is authorized to issue is 100,000,000, of which 80,000,000 shares are designated as common shares with a par value of \$0.01 per share and 20,000,000 shares are undesignated with a par value \$0.01 per share. The shares shall be divisible into classes and series, have the designations, voting rights, and other rights and preferences, and be subject to the restrictions, that the Board of Directors may from time to time establish, fix and determine, consistent with the Articles of Incorporation.

Shares of any class or series of the Corporation, including shares of any class or series which are then outstanding, unless otherwise specifically provided in the terms and preferences of any such particular class or series, may be issued to the holders of shares of another class or series without the authorization, approval or vote of the holders of shares of any class or series of the Corporation."

FURTHER RESOLVED, that the foregoing changes will be effective upon the date of filing with the Office of the Minnesota Secretary of State.

- 3. The foregoing amendment was adopted May 17, 2002, according to Chapter 302A of the Minnesota Business Corporation Act.
