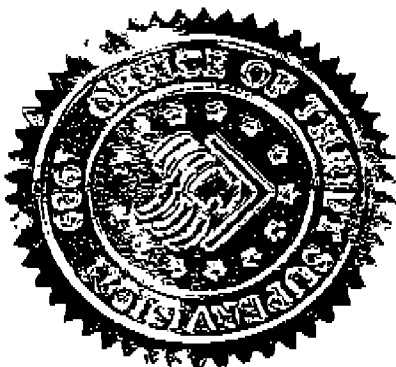
NAME CHANGE CERTIFICATION



I, Nadine Y. Washington, Corporate Secretary, Office of Thrift Supervision, hereby certify, according to the records of the Office of Thrift Supervision, Department of the Treasury, Washington, DC.:

1. Webster Bank, Waterbury, Connecticut, was chartered under the laws of the United States to transact the business of a Federal savings bank,
2. The charter of Webster Bank is in full force and effect;
3. The present corporate title of Webster Bank was effective November 1, 1995;
4. The immediate predecessor in corporate title to Webster Bank was Bristol Savings Bank, Bristol, Connecticut; and
5. Effective November 1, 1995, Bristol Savings Bank converted from a State-chartered savings association to a Federally-chartered savings bank under the corporate title of Webster Bank. Simultaneously, Webster Bank merged with First Federal Bank, a federal savings bank, Waterbury, Connecticut, and Webster Bank was the resulting institution.
