**RELEASE OF**  
**TRADEMARK SECURITY AGREEMENT AND CONDITIONAL ASSIGNMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT AND CONDITIONAL ASSIGNMENT (this "Release") is made as of the 21st day of January, 1993, by BANK OF AMERICA NATIONAL TRUST AND SAVINGS (the "Agent") on its behalf and on behalf of the Banks which are parties to the Credit Agreement referred to below.

**W I T N E S S E T H:**

WHEREAS, the Agent, the Banks, Levi Strauss & Co., a Delaware corporation ("Pledgor"), and Levi Strauss Associates Inc., a Delaware corporation, entered into that certain Credit Agreement dated as of April 3, 1991 (the "Credit Agreement"); and

WHEREAS, pursuant to the Credit Agreement, Pledgor and the Agent entered into the Trademark Security Agreement and Conditional Assignment, dated as of April 17, 1991, which was recorded with the United States Patent and Trademark Office on April 17, 1991 at Reel 0777, Frames 709 through 743 (the "Security Agreement"; capitalized terms having the meaning given to them in the Security Agreement); and

WHEREAS, by such Security Agreement, Pledgor granted to the Agent and the Banks a mortgage and security interest in and a conditional assignment of certain Trademarks and the Associated Goodwill of the business symbolized thereby; and

WHEREAS, the Agent and Banks have agreed to release their rights as mortgagee and secured party under the Security Agreement and to reconvey to the Pledgor any and all rights they may hold in the Collateral, including, but not limited to, those trademarks and trademark registrations identified on Schedule A, attached hereto and made a part hereof (the "Released Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Agent, for itself and on behalf of Banks, agrees as follows:

1. Release. The Agent hereby releases the mortgage and security interest in and to the Released Collateral, reconveys, assigns and transfers to Pledgor, without recourse or representation or warranty, express or implied, all of its right, title and interest in and to the Released Collateral, including the right to recover for all past, present and future

infringements thereof, and releases all other rights it may have under said Security Agreement.

2. Further Assurances. Agent shall execute such further documents as Borrower may reasonably request to give effect to this Release.

3. Governing Law. This Release has been executed and delivered pursuant to and shall be governed by and construed in accordance with the laws of the State of California.
