TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is effective as of this 12th day of August, 2002, by and between David E. Preng ("Assignor"), an individual; and Community National Bank ("Assignee"), a national banking association located at 5309 1/2 Bissonnet Boulevard, Bellaire, Texas 77401 The Assignor and Assignee are collectively referred to herein as the "Parties."

WHEREAS, the Assignor is the owner of certain trademarks, service marks and trade names as represented by the mark COMMUNITY NATIONAL BANK, including its related U.S. Trademark Application Serial No. 78/090,240 (including all domestic and foreign rights, registrations, and applications related thereto, collectively, the "Trademarks"); and

WHEREAS, the Assignee is now interested in acquiring the Trademarks from the Assignor, as part of the business to which the Trademarks pertain, and the Assignor is interested in transferring the Trademarks to the Assignee;

NOW, THEREFORE, subject to the terms, conditions, covenants and provisions of this Assignment, and for ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto, intending legally to be bound, agree as follows:

1. Assignor hereby sells, assigns, transfers and conveys to the Assignee, its successors and assigns, the Assignor's entire right, title and interest in and to (i) the Trademarks and their associated foreign and domestic applications, registrations and common law rights, together with the goodwill of the business associated with and symbolized by the Trademarks; and (ii) all causes of action, past, present, and future for infringement or unfair competition with respect to the Trademarks.

2. Assignor will, upon written request of Assignee, its successors and assigns, execute reasonable documents prepared at the expense of Assignee, its successors and assigns, to perfect its title to any and all rights in the Trademarks conveyed hereunder.

3. Assignor further authorizes and requests the United States Commissioner of Patents and Trademarks, as well as the applicable trademark registration authority for those countries in which applications for the Trademarks are pending, to issue any and all registrations resulting from the Trademarks to Assignee as owner of the entire interest in the Trademarks.

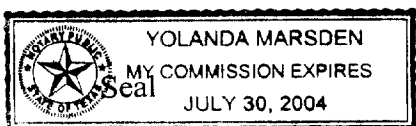
4. This Assignment shall be governed by and construed in accordance with the laws of the State of Texas, without reference to choice of law principles.
