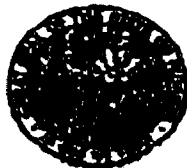

SECOND: The date of the amendment's adoption was February 10, 1999.

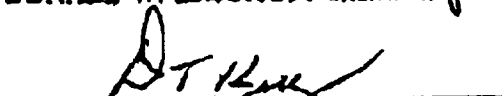
THIRD: The amendment was approved by the sole shareholder, Digital Solutions, Inc.
