NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS is made as of October 24, 2002 by SEQUEL LIMITED PARTNERSHIP III, in its capacity as the collateral agent on behalf of the Credit Parties ("Collateral Agent") for the benefit of STREAMPOINT FINANCIAL, INC., a Delaware corporation ("Company").
