INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), effective as of August 12, 2002 (the "Effective Date"), is made and entered into by and between GE Investments, Inc., a Nevada corporation ("GEII"), and General Electric Company, a New York corporation ("GE") (each a "Party," and collectively, the "Parties").

WHEREAS, pursuant to that certain Plan of Complete Liquidation of GEIS, as of even date herewith, and that certain Intellectual Property Assignment, effective as of even date herewith (the "GEIS IP Assignment"), by and between GEII and GE Information Services, Inc., a Delaware corporation ("GEIS"), GEII acquired all right, title and interest in and to the GEIS Intellectual Property (as defined in the GEIS IP Assignment);

WHEREAS, the Board of Directors of GEII has determined that it is in the best interests of GEII and its shareholders to declare a dividend of certain assets of GEII, including, without limitation, the GEIS Intellectual Property acquired by GEII from GEIS; and

WHEREAS, in order to effectuate the aforementioned dividend, GEII agrees to assign, transfer and convey to GE, the sole holder of Class A Common Shares of GEII, all of GEII's right, title and interest in and to the GEIS Intellectual Property.


NOW THEREFORE, the Parties agree as follows:

1. Assignment. GEII hereby, effective as of the Effective Date, assigns, transfers, conveys and quitclaims to GE all of GEII's right, title and interest in and to all GEIS Intellectual Property, including, without limitation, those items of GEIS Intellectual Property listed on Schedule A attached hereto.
2. Recordation of Patents, Trademarks and Copyrights. If GE elects to record this Assignment with the U.S. Patent & Trademark Office, U.S. Copyright Office or applicable state or foreign governmental or international authorities or registries, GE shall bear all costs and fees associated with such recording. GEII hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, Register of Copyrights of the United States and any official of any state or foreign country whose duty it is to issue intellectual property registrations, to issue all registrations from any applications for registration included in the GEIS Intellectual Property to GE.
3. Governing Law and Forum. This Assignment shall be governed by, and construed exclusively in accordance with, the laws of the State of New York.
4. Counterparts. This Assignment may be executed in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement.


