



SERVICE MARK ASSIGNMENT


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which Assignor acknowledges:

4. The Assignment shall be binding upon Assignor, Assignor's successors and assigns, and upon all others acting by, through, with or under Assignor's direction or control, and all those in privity therewith.
