The Combined Section 8 Affidavit and Section 9 Renewal Application was received on 06-20-2002. Renewal is granted. However, the Section 8 Affidavit is refused for the following reason(s):

The Trademark Act requires that the current owner of the registration file the Section 8 Affidavit. 15 U.S.C. §1058. It is unclear whether the party who filed the Section 8 Affidavit is the current owner.

Office records show ANK II, INC. rather than AMYCEL, INC., as the owner of the registration. The information submitted is sufficient to establish ownership of the registration by AMYCEL, INC.. 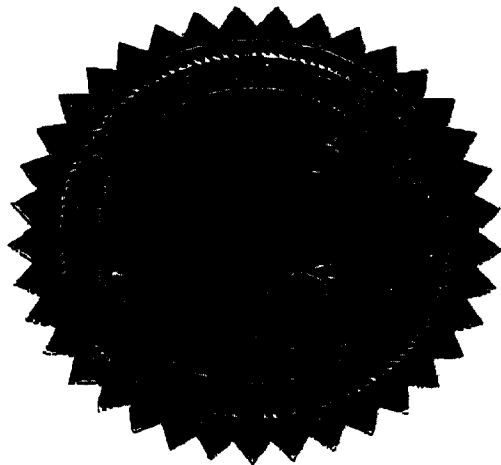
