RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Agreement") is made as of the 4th day of February, 2003, between Verestar, Inc., a Delaware corporation, successor by merger to ICG Satellite Services, a Colorado corporation formerly known as ICG Wireless Services, Inc. ("ICG"), and Maritime Telecommunications Network, Inc., a Colorado corporation ("MTN").

WHEREAS, ICG and MTN entered into a trademark security agreement titled "Conditional Assignment of Trademarks" in connection with certain loan documents and recorded the security agreement with the United States Patent and Trademark Office on or about June 12, 1995 at Reel 001361, Frame 0660, for the purpose of securing certain obligations of MTN to ICG;

WHEREAS, pursuant to the trademark security agreement, MTN granted ICG a continuing security interest in certain of its marks, including without limitation the trademarks identified on Schedule A attached hereto (the "Marks"), and pledged and mortgaged (but did not transfer title to) the Marks to ICG;

NOW, THEREFORE, for valuable consideration and pursuant to the terms and conditions set forth in the trademark security agreement:

ICG hereby terminates and releases its security interest in the Marks, including without limitation the Marks identified on Schedule A attached hereto, effective as of the date set forth above.
