TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT ("Agreement") is made by and between COMPASS CONCEPTS, INC. ("Assignor"), a corporation having its principal place of business at 467 Forbes Boulevard, So. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby, by these presents, convey, set over, grant, sell, transfer, assign and deliver to Assignee the all of Assignor's right, title and interest in and to the Property as of the Effective Date. Assignee, its successors and assigns, shall have and hold the Property for its own use and benefit forever.
