

### TRADEMARK ASSIGNMENT

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the parties hereto agree as follows;

(1) ADC Telecommunications, Inc., a corporation of the state of Minnesota ("ADC" or "Assignor"), having an office and place of business at 13625 Technology Drive, Eden Prairie, MN 55344-2252, and the owner of all right, title and interest to the Trademarks listed below (the "Marks"); hereby sells, assigns and transfers unto Broadband Royalty Corp., a corporation of the state of Delaware ("Assignee"), having an office and place of business at 60 Decibel Road, State College, PA 16801, its successors, assigns and legal representatives, its entire right, title and interest in and to the Marks.

(2) Assignor hereby agrees that it will from time to time, if reasonably so requested by the Assignee or the successors or assigns of the Assignee, execute, acknowledge and deliver, or cause to be executed and delivered to Assignee or its successors or assigns such and all further acts, transfers, assignments, transfer documents, powers and assurances of title and additional papers and instruments that may be necessary or desirable to carry out the intent hereof and to vest in Assignee the entire right, title and interest of Assignor in and to the Marks throughout the world. Assignor agrees that it will, if reasonably so requested by the Assignee or the successors or Assigns of the Assignee, assist Assignee or its successor or assigns with applications to register any of the Marks in any jurisdiction in the world where they are not now registered including, without limitation, helping to establish priority of use or satisfy any other predicates for registration. The Assignee or successors or assigns of the Assignee shall pay all of the Assignor's reasonable expenses in performing any of the duties required of the Assignor in this Section 2.

(3) All capitalized terms used but not defined herein shall have the meaning assigned to such terms in the Acquisition Agreement, dated as of July 9, 2001 and as amended on August 4, 2001, by and among C-COR.net, Broadband Capital Corp., Assignee and C-COR Europe Holding, B.V. and Assignor, ADC Broadband Communications, Inc., ADC International Holding Company, ADC Phasor Electronics, GmbH and ADC Argentina, S.R.L. (the "Acquisition Agreement"). Assignor and Assignee hereby acknowledge and agree that neither the representations and warranties nor the rights, remedies and obligations of any party under the Acquisition Agreement shall be deemed enlarged, modified or altered in any way by this Trademark Assignment Agreement.

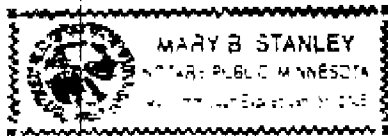
